SECTION 3: GRANT OF RIGHTS

SECTION 5: ADDITIONAL TERMS

I understand that no compensation will be provided for the use of Media. This release is valid for all Back on Track events during the current season and any future seasons unless revoked in writing. I may revoke this consent at any time by providing written notice to the Meet Director. Revocation will not affect Media already published or distributed prior to the date of revocation.

The Organization will make reasonable efforts to respect consent selections and will not intentionally use Media of participants who have declined consent. However, the Organization cannot guarantee that a participant will not appear incidentally in wide-angle or group photographs.
